

LAKEMONT TREE POLICY

WHEREAS, the property encumbered by this Tree Policy is that property initially restricted by the First Amended Declaration of Covenants, Conditions and Restrictions for Lakemont recorded under Fort Bend County Clerk's File No. 2003032959, as same has been and may be amended from time to time (referred to hereinafter as the "Declaration"), and any other subdivisions which have been and may be subsequently annexed thereto and made subject to the authority of the Lakemont Community Association, Inc. (the "Association"). All capitalized terms are defined as set out in the Declaration unless otherwise noted herein; and

WHEREAS, pursuant to the authority vested in the Architectural Review Committee (the "ARC") in the Declaration, the ARC has established a list of preferred trees for use within the Lakemont subdivision, which is set forth in the Lakemont Design Guidelines; and

WHEREAS, the Board of Directors of the Association and the Lakemont ARC have adopted a Resolution amending that portion of the Lakemont Design Guidelines prohibiting palms, other than Sago Palms, to be viewed from public streets to allow palms to be viewed from public streets if approved by the ARC; and

WHEREAS, the Board of Directors of the Association and the Lakemont ARC have duly adopted the list of preferred trees as set out in the Lakemont Design Guidelines. Owners of Lots within Lakemont should review the Lakemont Design Guidelines to become familiar with the type of trees that may be planted within the Lakemont subdivision.

NOW THEREFORE, the following approved trees have been adopted by the Board of Directors of the Association and the ARC, and shall be added to the list of preferred trees set forth in the Lakemont Design Guidelines that may be planted within the Lakemont subdivision:

- Palm Trees

All tree installations must additionally conform to all other ARC requirements, including but not limited to: prior written approval by the ARC, placement, caliper size, and location.

This Tree Policy has been duly adopted by the Lakemont Community Association, Inc., and the Lakemont Architectural Review Committee to be effective upon the recording of this Tree Policy in the Real Property Records of Fort Bend County, Texas.

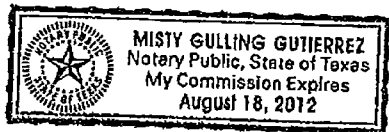
